**ORDER**

**AND NOW**, this 26th day of December, 2024, the Monroe County Probation Department having maintained custody of the attached list of confiscated firearms, and no person having motioned for return of same, **IT IS ORDERED AND DIRECTED** that the Monroe County Probation Department publish this Administrative Order in the Monroe County Legal Reporter and publish the attached list of firearms on the Court’s website. The Probation Department shall also have the following language published in at least one additional local publication:

Department will destroy all remaining firearms.”

Any party associated with a firearm seeking to retain same must contact Court Administration by email at [jspencer@monroepacourts.us](mailto:jspencer@monroepacourts.us) within thirty (30) days from the date of this publication.

Upon the expiration of thirty (30) days from publication of this Order and the attached list, and without further order, notice, or publication, the Monroe County Probation Department may destroy all remaining exhibits through a certified firearms destruction company.
